IMPOT / IMPORTS

JADUAL PERTAMA / FIRST SCHEDULE
LARANGAN IMPOT / PROHIBITED IMPORTS

- ❖ Opium and Chandu;
- ❖ Java Sparrow;
- ❖ Prohibited publication by any order made under the Sedition Enactment or the Undesirable Publication Enactment;
- ❖ Fire crackers – known as 'Double Bangers';
- ❖ Vaccines of Taiwan origin;
- ❖ Cigarettes without health warning written on their package;
- ❖ Pencil-like syringe;
- ❖ Pigs bred in or exported from Thailand;
- ❖ Eggs for hatching purposes and fresh eggs unless such eggs are clearly stamped with non-erasable ink or such like substance with the word 'IMPORTED' on the shell;
- ❖ Fabrics of tissues consisting of any fibre whatsoever and any other article whatsoever which fibre or tissue or other articles bear the imprint of any currency notes, bank note or coin which are or have at any time been issued or currency in any country whatsoever.

JADUAL KEDUA / SECOND SCHEDULE
SEKATAN IMPOT / RESTRICTED IMPORTS

- ❖ Any living plants or planting materials (Except from Sarawak and North Borneo);
- ❖ Live cattle and birds (Except from Sarawak and North Borneo);
- ❖ Pin table, fruits machines, slot machines and any other tables or machines of a like nature whether involving an element of chance or not;
- ❖ Persian glue, Poh Ka, Poh Kah or Poh Kau, Koyoh or Koyok, Liow Ko, Ch'ow Ko;
- ❖ Poisons and deleterious drugs;
- ❖ Rice paddy and the products thereof;
- ❖ Separated skimmed or filled milk;
- ❖ Sugar, salt and converted timber;
- ❖ Used (including reconditioned) motor cars, motor cycles, lorries, omnibuses, including minibuses, tractors and trailers;
- ❖ Alcoholics liquors;
- ❖ Any radioactive materials;
- ❖ Beef including the carcass of the animal or any part thereof, the meat (whether frozen, chilled or fresh), bones, hide, skin, hooves, horns, offal or any other part of the animal, or any portion thereof, unless it has been slaughtered in an abattoir approved in writing by the Minister of Religious Affairs;
- ❖ Poultry, including the carcass of the bird or any part thereof, the meat (whether frozen, chilled or fresh), bones, skin, offal or any other part of the animal, or any portion thereof, unless it has been slaughtered in writing by the Minister of Religious Affairs;
- ❖ Fireworks, Smoking Pipe, Tobacco, including tobacco product (as defined in the Tobacco Order, 2005) and Vaporisers (vape) including e-liquid;
- ❖ Used Tyres;
- ❖ Rhinoceros horn and all other parts of or products derived from the carcass of a rhinoceros;
- ❖ Hydrofluorocarbons, whether as pure substance or in mixtures as specified in Customs (Prohibition and Restriction on Imports and Exports) (Amendment) Order, 2005.
